

## **TERMS AND CONDITIONS**

**TUITION AND FEES:** I, the legal parent or guardian, understand that tuition is due by the 5<sup>th</sup> of each month, all tuition is set up via ACH out of financial institution of client's choice. There will be a \$25 ACH charge for insufficient funds. Tuition is based on the number of enrolled monthly classes, no prorate for missed days, holidays, inclement weather closings or school vacations. ACH form provided upon registration sent via your email of choice along with the Studio Handbook. ACH form must be returned immediately once registered.

- Annual registration fee of \$25 per student or \$35 per family for REGULAR DANCE SEASON ONLY, this fee
  is nonrefundable upon registration.
- Basement Recital Fee of \$35 per student plus t-shirt (average \$15) and costume fee (average \$70) will be paid in two installments in February and March
- If student unenrolls at any time during the regular dance season, a\$150 cancellation fee will be assessed, we rely on the commitment of students and their parents/guardians.
- THERE IS NO REGISTRATION FEE FOR OUR 6-week sessions
- 6-week sessions must have a minimum of 5 students and must be paid 2 week in advance of session, send payment to: The Basement Dance Studio, 2705 N Main Street, Elkhorn, NE 68022

**PHOTO RELEASE:** Basement Dance Studio (BDS) will include photos of student BDS, teachers, and activities on its website, social media outlets and printed materials. I understand that these pictures will be accessible to anyone with internet access. I give my permission for BDS to use photos of my child/children on its website, on Facebook, Instagram, in printed materials, and in electronic forms of communication. I understand that if I do not want images of my child to be used, I will indicate this in writing and a signed letter will be emailed to Lynlee Medhi before student begins any classes at BDS.

**MEDICAL RELEASE:** I give my permission for BDS to transport, call an ambulance, or to take my child to a medical/dental facility, if necessary. In case of emergency, if none of the emergency contacts respond, I hereby give my consent for emergency medical care to be prescribed by a duly licensed Doctor of Medicine or Doctor of Dentistry. This care may be given under whatever conditions are necessary to preserve the life, limb, or well-being of my dependent. I accept full responsibility for all costs of said medical care and any emergency treatment. BDS will not be held responsible for the cost of any medical or dental care, or emergency treatment. I hereby waive all claims whatsoever in connection with such medical treatment.

**WAIVER AND RELEASE:** I agree that if my dependent or I (heretofore known as "we") engage in any physical activity, class, or activity, or facility on the premises or any venue where we participate as a representative of BDS, we do so at our own risk. I agree that we are voluntarily participating in activities and use of said facilities, premises (including the parking lot) and designated BDS venues. We assume all risk of injury, illness, damage, or loss to us or our personal property that might result, including, without limitation, any loss or theft of any personal property. I agree that this consent and assumption of risk statement covers each and every event or activity sponsored by BDS. I agree to release and discharge you (and your affiliates, employees, assistant, volunteers, agent, representatives, successors, and assigns) from any and all claims or cause of action (known or unknown) arising out of your negligence. I acknowledge that I have carefully read this Waiver and Release and fully understand that it is a release of liability. I am waiving any right that I may have to bring legal action to assert a claim against you for negligence.

ANY PERFORMANCE (including recital): By signing this, I am aware that my child is committed to performing in various performances, specifically recital at the conclusion of the dance season they are registered for. If your child is not going to participate in the performance, please let Lynlee Medhi know, in writing, no later than the first dance season class.

**DECLARATION**: By electronically checking the terms and condition box, I confirm that I have read the document in its entirety. I understand the document, have had an opportunity to ask questions, and agree to be bound by its terms.
